

# POHL RECREATION CENTER MEMBERSHIP AGREEMENT

## University Of North Texas Pohl Recreation Center Membership Agreement

This Pohl Recreation Center Membership Agreement (hereinafter "Agreement") is entered into by and between the University of North Texas Recreational Sports Department and the undersigned Pohl Recreation Center User ("User"). All members of the Rec Center and guests are subject to the terms and conditions of this Agreement and the facility policies.

### ELIGIBILITY, PRIVILEGES AND RULES

#### Eligibility:

- All currently enrolled students, currently employed or retired faculty and staff, their spouses, sponsored adults, and alumni (with current alumni association membership) are eligible to purchase a membership.
- Individuals sponsoring a membership must provide current proof of eligibility. All memberships require the appropriate ID to be presented at time of purchase (i.e. UNT student ID, faculty ID or staff ID, etc.).
- Current and retired faculty and staff employees and currently enrolled students may sponsor one individual for membership defined as the Plus One membership type. Individuals must be 18 years or older at the time of membership, live full-time in the same residence as the sponsoring member during the term of the membership, and show written proof of eligibility and residence. Proof of eligibility and residence includes a current driver's license showing age and residence, a utility bill or bank account jointly reflecting the name of the member and person being sponsored, or marriage license. The sponsoring member must appear in person each time the membership is purchased or renewed to verify his or her agreement to sponsor the individual, but does not need to be a current UNT Pohl Recreation Center member. Individuals who misrepresent their eligibility for membership or who sponsor an individual who is not eligible for membership will have their membership permanently revoked and be subject to disciplinary action. No refund will be given when a membership is revoked.
- Dependents will be registered under the student/employee's ID. Faculty, staff and students registering dependents must do so in person.
- Membership must be renewed each year for student Plus One and/or student dependents.
- All Plus One members and dependents 16-24 must have their own Rec Center membership card or app login to use the facility. Members and guests are required to follow all posted rules.

**Guests and Supervision:** Any member may sponsor up to two individuals per day as guest(s) for a fee. The member must be in the facility with the guest(s) at all times and is responsible for his/her guest's conduct. Guests must provide photo identification (i.e., driver's license, school I.D.). The eligible user must present his/her UNT ID card to obtain the guest pass. The guest pass is valid only for the date listed on the receipt.

**Equipment Checkout and Use:** Equipment is available for checkout from the member services desk with a valid UNT ID, Rec Center membership card, or app login. Guests may not check out equipment. Members may check out equipment for their guests. Equipment must be returned in the condition it was checked out. Members will be charged for the cost of replacing or repairing lost, stolen or damaged equipment.

**Admission:** Members must have a current UNT photo I.D. card, Rec Center membership card, or app login to use the facility. Members who do not have the proper identification may be denied use of the facility. Users are allowed to forget their ID card 3 times per semester.

**Age and Use Restrictions:** Members and guests under 16 years of age may not use the climbing wall, group exercise classes, weight room/equipment, or racquetball courts. An adult sponsor may supervise unlimited family members and/or no more than two (2) individuals under 16 years of age. A parent or guardian over 18 must directly supervise individuals under 16 years of age when using the Rec Center. Children 4 years of age and younger may be in the locker room of the opposite sex only when under the direct supervision of a parent or guardian. Unisex restrooms are available on the north side of the facility for your use. Failure to follow age and use restrictions may result in termination or suspension of membership or guests privileges.

### MEMBERSHIP AND GUEST FEES, CANCELLATION POLICY AND METHODS OF PAYMENT

**Guest Fees:** This membership does not include guest fees.

**Lost or Stolen items:** Recreational Sports is not responsible for any lost or stolen items from the Pohl Recreation Center.

**Lockers available:** Day use lockers are free to use throughout the facility and already have locks on them. Padlocks are available for checkout from the member services desk to use on the Day Use Lockers in the locker rooms. Full or half lockers are available to rent.

**Facility Closures:** The Pohl Recreation Center will be closed during some university holidays. The holiday schedule of hours will be posted. There may be one to two weeks during the year when maintenance may require areas to be closed. Members will receive notification prior to this occurrence.

**Membership Cancellation Policy:** Memberships, Locker Rentals, and Towel Service can be cancelled by contacting the Recreational Sports office or sending your cancellation request to [Ryan.Comfort@unt.edu](mailto:Ryan.Comfort@unt.edu) or [Laura.Palacios@unt.edu](mailto:Laura.Palacios@unt.edu). Cancellations will take effect at the end of the month the request was received. Refunds for all other purchases will be considered on a case by case basis. Please contact Recreational Sports with questions. All approved refunds will be processed by the method below that corresponds to your original purchase:

1. In-person payments made by credit card will be refunded to the original card used at the time of payment.
2. Online purchases will automatically credit the card used for purchase.
3. Cash and check payments will be refunded via campus issued check and may take up to 30 days to process.
